**Question No : 6**

You administer a Windows Azure SQL Database database named Inventory that contains a stored procedure named p\_AddInventory.

Users need to be able to SELECT from all tables in the database and execute the stored procedure. You need to grant only the necessary permissions.

What should you do?

- A. Add EXECUTE AS OWNER to the stored procedure. Add all users to the db\_datareader role.
- B. Add all users to the db\_datawriter role. Add all users to the db\_datareader role.

**Explanation:** In SQL Server you can define the execution context of the following user-defined modules: functions (except inline table-valued functions), procedures, queues, and triggers.

By specifying the context in which the module is executed, you can control which user account the Database Engine uses to validate permissions on objects that are referenced by the module. This provides additional flexibility and control in managing permissions across the object chain that exists between user-defined modules and the objects referenced by those modules. Permissions must be granted to users only on the module itself, without having to grant them explicit permissions on the referenced objects. Only the user that the module is running as must have permissions on the objects accessed by the module.

**Question No : 7 DRAG DROP**

You administer a Microsoft SQL Server 2012 database.

All database traffic to the SQL Server must be encrypted by using secure socket layer (SSL) certificates or the connection must be refused.

Network administrators have deployed server certificates to the Windows store of all Windows servers on the network from a trusted Certificate Authority. This is the only Certificate Authority allowed to distribute certificates on the network.

You enable the Force Encryption flag for the MSSQLServer protocols, but client computers are unable to connect. They receive the following error message:

"A connection was successfully established with the server, but then an error occurred during the pre-login handshake, (provider: SSL Provider, error: 0 - The certificate chain was issued by an authority that is not trusted.) (Microsoft SQL Server)"

You notice the following entry in the SQL Server log:

"A self-generated certificate was successfully loaded for encryption."

You need to configure SQL Server to encrypt all client traffic across the network. You also need to ensure that client computers are able to connect to the server by using a trusted certificate.

**Question No : 8**

You administer a Microsoft SQL Server 2012 database that has Trustworthy set to on. You create a stored procedure that returns database-level information from Dynamic Management Views.

You grant User1 access to execute the stored procedure.

You need to ensure that the stored procedure returns the required information when User1 executes the stored procedure. You need to achieve this goal by granting the minimum permissions required.
