**Explanation:** You can begin using a data loss prevention (DLP) solution in your messaging environment by using the following procedures.

\* (B) Create a DLP Policy From a Template

Information to help you configure a Microsoft-supplied, pre-built set of policy rules. Policy templates are an easy way to get started with managing message data that is associated with several common legal and regulatory requirements.

\* (C) Import a DLP Policy From a File Information to help you import a file that contains policy information settings. Policies that are created independent of Exchange as XML files must meet specific format requirements in order to work correctly.

\* (D) Create a Custom DLP Policy

Information to help you configure policy rules to meet the specific needs of your organization which may not be covered in one of the pre-existing DLP templates. The rule conditions that are available to you in a single policy include all the traditional transport rules in addition to the new sensitive information types.

**Question No : 6**

You need to migrate from an on-premises installation of Microsoft Exchange Server 2003 to Office 365.

**Answer: A,C,E**

**Explanation:** A: The cutover migration option is for customers who want to migrate their whole environment at one time. This migration is limited to less than 2,000 mailboxes and is targeted at small to medium-sized business customers who are running Exchange 2003 or a later version in their environment.

C: Staged migration enables migration from an on-premises Exchange 2003 or Exchange 2007 deployment. The main difference in this kind of migration is that the migration is targeted at customers who want to establish a permanent mail coexistence with Exchange Online and their on-premises environments.

E: IMAP migration is targeted at customers who may be using non-Exchange-based mail systems in their current hosted environment or have access to the data only by using the IMAP 4 protocol. The Office 365 migration engine uses the information that's provided by IT admins in the EAC to connect to IMAP mailboxes and download mailbox data. IT admins must provide a list of users to migrate in each batch by using a CSV file.

**Explanation:** A: Connection filtering

The spam filters first check the IP Allow and IP Block lists and filter inbound messages according to the specifications of both lists. Messages that are sent from allowed IP addresses are not subject to further spam filtering; for example, content filtering is bypassed. Furthermore, messages from an IP address that appears on both lists are allowed. IP Allow and IP Block lists are empty by default and must be configured by editing the default connection filter policy.

BC: Content filtering include International Filtering:

You can choose to filter email messages written in specific languages, or sent from specific countries or regions.

**Explanation:** B (not D): Remote move enables migration from a deployment of Exchange 2010 or later versions.

Note:

\* A remote move migration is used to migrate on-premises Exchange mailboxes to Exchange Online in an Exchange hybrid deployment. You must have an Exchange hybrid deployment to use a remote move migration.

\* With a hybrid deployment, you get the following capabilities:

User account management in your on-premises organization.

Directory synchronization between your on-premises and Exchange Online organizations.

Single sign-on to mailboxes located either on-premises or in the Exchange Online organization.

Secure mail routing between on-premises and Exchange Online organizations.

Free/busy and calendar sharing between on-premises and Exchange Online organizations.

Even if you plan to permanently move your on-premises email organization to Exchange Online and Office 365 over a longer period of time, you can take advantage of these hybrid deployment features during the transition.

\* Microsoft Connectivity Analyzer Tool 1.0

We are excited to announce the 1.0 release of the Microsoft Connectivity Analyzer. This tool is a companion to the Microsoft Remote Connectivity Analyzer web site. The MCA tool

provides administrators and end users with the ability to run connectivity diagnostics for five common connectivity symptoms directly from their local computer. Users can test their own connectivity, and save results in an HTML format that administrators will recognize from viewing results on the RCA website.

\* The MCA tool offers five test symptoms:

“I can’t log on with Office Outlook” – This test is equivalent to the Exchange RCA test for “Outlook Anywhere (RPC over HTTP)”. There is an option to run the SSO test provided on the parameters page.

“I can’t send or receive email on my mobile device”. – This test is equivalent to the Exchange RCA test for Exchange ActiveSync.

\*\*\*New MCA Test\*\*\* “I can’t log on to Lync on my mobile device or the Lync Windows Store App” – This test checks for the Domain Name Server (DNS) records for your on-premise domain to ensure they are configured correctly for supporting Mobile Lync clients. Also it connects to the Autodiscover web service and makes sure that the authentication, certificate, web service for Mobility is correctly set up

\*\*\*New MCA Test\*\*\* “I can’t send or receive email from Outlook (Office 365 only)” – This test checks Inbound/Outbound SMTP mail flow and also includes Domain Name Server validation checks for O365 customers.

\*\*\*New MCA Test\*\*\* “I can’t view free/busy information of another user” – This test verifies that an Office 365 mailbox can access the free/busy information of an on-premises mailbox, and vice versa (one direction per test run).

C:

\* Microsoft Remote Connectivity Analyzer (RCA) is a web-based tool that can help you confirm that connectivity for Exchange servers is configured correctly and to diagnose any connectivity issues.

\* Microsoft Remote Connectivity Analyzer is a web site that allows you and your users to quickly test connectivity, availability & functionality of your on-premises Exchange and Lync servers and Office 365 services.

not B: Lync Online Transport Reliability IP Probe (TRIPP) tool is a Java-based tool that checks the transport path between the computer and a Lync Online data center for possible issues.
